COURSE:

8 LANE, 25 YD COMPETITION POOL DEPTH 7-9 FEET, LANES 9 FEET WIDE ADJACENT WARM-UP/WARM-DOWN THROUGHOUT MEET COLORADO TIMING SYSTEM WITH SCOREBOARD ALL EVENTS CONTESTED IN ONE POOL

WARM-UP:

NO ASSIGNED LANES FOR GENERAL WARM-UP. PACE AND SPRINT LANES WILL OPEN 40 MINUTES PRIOR TO THE START OF EACH SESSION AND ANNOUNCED OVER PA SYSTEM. THE POOL WILL BE CLEARED 10 MINUTES PRIOR TO THE START OF EACH SESSION.

SESSION ONE: FRIDAY, NOVEMBER 21st - PRELIMS: WARM-UP 8:30 AM-STARTS 10:00 AM SESSION TWO: FRIDAY, NOVEMBER 21st - FINALS: WARM-UP 4:30 PM-STARTS 6:00 PM SESSION THREE: SATURDAY, NOVEMBER 22nd - PRELIMS: WARM-UP 8:30 AM-STARTS 10:00 AM SESSION FOUR: SATURDAY, NOVEMBER 22nd - FINALS: WARM-UP 4:30 PM-STARTS 6:00 PM SESSION FIVE: SUNDAY, NOVEMBER 23rd - PRELIMS: WARM-UP 8:30 AM-STARTS 10:00 AM SESSION SIX: SUNDAY, NOVEMBER 23rd - FINALS: WARM-UP 3:30 PM-STARTS 5:00 PM

TIME TRIALS:

IMMEDIATELY FOLLOWING THE CONCLUSION OF PRELIMS ON FRIDAY AND SATURDAY AND BEFORE THE 1650 DURING PRELIMS ON SUNDAY; ALSO DURING THE 20 MINUTE BREAKS BE-FORE RELAYS IN THE FINAL SESSIONS. ALL TIME TRIALS WILL START WITH THE CURRENT DAY'S EVENTS AND THEN MOVE TO THE FOLLOWING DAY THEN PRECEDING DAYS; I.E. SAT-URDAY TIME TRIALS START WITH SATURDAY EVENTS, THEN SUNDAY, THEN FRIDAY. PLEASE, NO TIME TRIALS FOR PERSONAL BESTS, TEAM RECORDS, FRESHMAN RECORDS, ETC. TIME TRIAL ENTRIES WILL BE TAKEN UNTIL 1 HOUR AFTER THE BEGINNING OF EACH SESSION. TO-TAL TIME FOR EACH TIME TRIAL SESSION WILL BE 20 MINUTES MAXIMUM.

FORMAT:

THE 1650 AND ALL RELAY EVENTS WILL BE CONTESTED AS TIMED FINALS WITH ALL RELAYS SWIMMING AT NIGHT. ALL PRELIM/ FINAL EVENTS WILL HAVE AN A, B, AND C FINAL. WE WILL SWIM FINALS IN CBA ORDER. PLEASE USE LIFE TIME BEST TIMES FOR THE 1650 EVENT AS SOME TEAMS MAY NOT CONTEST THE EVENT PRIOR TO THE INVITATIONAL. USE SEASONAL BEST TIMES IN ALL OTHER EVENTS INCLUDING RELAYS.

ENTRY LIMIT:

EACH SWIMMER IS LIMITED TO A MAXIMUM OF SEVEN (7) EVENTS WITH NO MORE THAN (4) FOUR INDIVIDUAL EVENTS. TIME TRIALS DO NOT COUNT TOWARD THE MAXIMUM, HOWEV-ER A SWIMMER MAY TIME TRIAL A SPECIFIC EVENT ONLY ONCE.

INDIVIDUAL & RELAY TEAM ENTRIES:

NO LIMIT! EACH TEAM MUST LIST (18) SCORERS FOR INDIVIDUAL EVENTS WITH A TEAM MAX-IMUM OF 25 TOTAL SWIMMERS PER GENDER; INDIVIDUAL SWIMMERS 19-25 MUST BE LISTED AS EXHIBITION. THIS ROSTER MUST BE SUBMITTED WITH ENTRIES. ALL TEAM MEMBERS ARE ELIGIBLE TO SWIM IN RELAYS, HOWEVER ONLY THE TWO (2) FASTEST RELAYS PER TEAM WILL BE ELIGIBLE TO SCORE.

EXHIBITION SWIMMERS WILL BE SEEDED LAST IN TIMED FINAL EVENTS WITH A LANE OF SEPARATION BETWEEN THEM AND SCORING SWIMMERS. EXHIBITION SWIMMERS CANNOT SWIM IN AN A, B, OR C FINAL UNLESS SCRATCHES, DISQUALIFICATIONS, OR ALL SCORING COMPETITORS ARE EXHAUSTED AND ONLY EXHIBITION REMAIN TO FILL A FINALS HEAT.

<u>1650</u>

THE 1650 IS A TIMED FINAL EVENT AND WILL BE LIMITED TO THE FASTEST 32 FOR EACH GEN-DER. IT WILL BE SEEDED AND SWUM SLOW TO FAST. ANY EXHIBITION SWIMS WILL BE SEED-ED LAST WITH A LANE OF SEPARATION BETWEEN THEM AND SCORING SWIMMERS. PLEASE SEE SUNDAY SCHEDULE FOR HOW THE 1650 WILL BE SWUM. IF WE DO NOT HAVE 4 HEATS, WE WILL CONDENSE USING A SIMILAR FORMAT LISTED, WITH THE FASTEST HEATS FOR EACH GENDER SWIMMING DURING FINALS.

SCRATCHES:

SCRATCHES FROM PRELIMINARIES MUST BE GIVEN TO THE HY-TEK OPERATOR BY 6:30 PM ON FRIDAY AND SATURDAY FOR THE FOLLOWING DAY'S EVENTS. SCRATCHES FOR FRIDAY'S EVENTS MUST TAKE PLACE BY WEDNESDAY, NOVEMBER 19 AT 5:00 PM TO LISA AT <u>lisa.olack@yahoo.com</u>. PLEASE KEEP IN MIND THAT RELAYS AND THE 1650 MUST BE POSITIVELY CHECKED IN BY THE ENTRY DEADLINES.

NO SHOWS:

IN ACCORDANCE WITH CHAMPIONSHIP RULES, A NO SHOW (FAILURE TO COMPETE) DURING ANY EVENT FOR PRELIM/FINALS, SWIM-OFFS, ETC. WILL DISQUALIFY A SWIMMER FROM THAT EVENT AND SHALL PROHIBIT FURTHER COMPETITION IN THE MEET.
